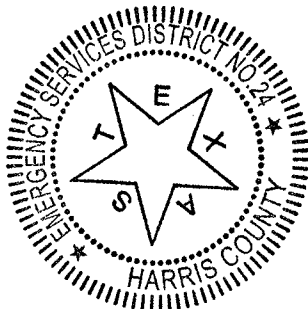

10. To review, discuss and take action on approval of pay applications.
11. To review and take action on granting exemptions for 2016.
12. To review, discuss and take action on requests from the Department and Administrative staff for equipment purchases, supply purchases, and capital expenditures.
