

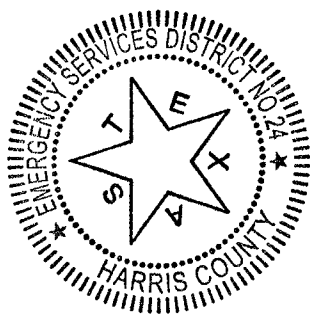
MEETING NOTICE

The District will consider and act upon the following matters:

6. To review and take action to approve an Order imposing the District's Sales and Use Tax as approved by the voters at the election held on May 7, 2016.

9. To review, discuss and take action on documents and submittals requested or presented by BRW Architects related to the Station 21 construction project.
