

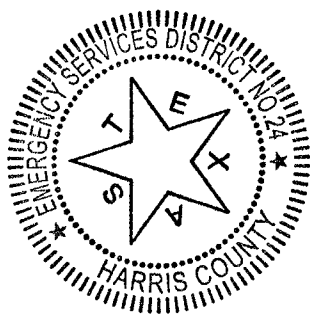
**MEETING NOTICE**
