

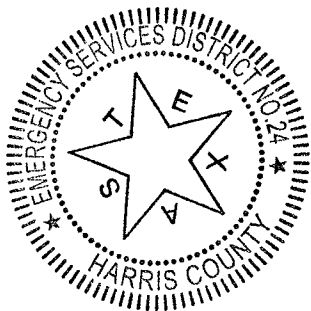
MEETING NOTICE

The District will consider and act upon the following matters:

6. To review, discuss and take action regarding the Chief's report including fire suppression, rescue and related activities.
7. To review and take action on the District 2017 budget.
8. To review and take action on the 2016 Tax Rate, including action to adopt a rate at or below the Effective Tax Rate or to propose a rate above the Effective Tax Rate and to schedule public hearings and to authorize publication of newspaper notices required by the Tax Code.
9. To review, discuss and take action on documents and submittals requested or presented by BRW Architects related to the Station 21 construction project.
10. To review, discuss and take any necessary action regarding change orders or any other construction matter related to the Station 21 construction project with LDF Construction, Inc.
