

# Notice of Public Hearing on Tax Increase

A tax rate of \$0.10 per \$100 valuation has been proposed by the governing body of **Harris County Emergency Services District No. 24**.

PROPOSED TAX RATE	\$0.100000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.086408 per \$100
VOTER-APPROVAL TAX RATE	\$0.089502 per \$100
DE MINIMIS RATE	\$0.093755 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for **Harris County Emergency Services District No. 24** from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that **Harris County Emergency Services District No. 24** may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for **Harris County Emergency Services District No. 24** exceeds the voter-approval rate for **Harris County Emergency Services District No. 24**.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for **Harris County Emergency Services District No. 24**, the rate that will raise \$500,000, and the current debt rate for **Harris County Emergency Services District No. 24**.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that **Harris County Emergency Services District No. 24** is proposing to increase property taxes for the 2022 tax year.

The proposed tax rate is also greater than the voter-approval tax rate and the de minimis rate. If **Harris County Emergency Services District No. 24** adopts the proposed tax rate, **Harris County Emergency Services District No. 24** is required to hold an election so that the voters may accept or reject the proposed rate. If a majority of the voters reject the proposed tax rate, the tax rate of the **Harris County Emergency Services District No. 24** will be the voter-approval rate of the **Harris County Emergency Services District No. 24**.

A **PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 24, 2022 at 11:00 a.m.** at Aldine Fire & Rescue Station No. 31, 20440 Imperial Valley Drive, Houston, TX 77073.

**Harris County Emergency Services District No. 24** may take action on the proposed tax rate on August 24, 2022 at 11:00 a.m., following the hearing to be held.

The election will be on November 8, 2022. You may contact the Harris County Clerk's Office – Election Department for information about voting locations. The hours of voting on election day are 7:00 a.m. to 7:00 p.m.

The 86<sup>th</sup> Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by **Harris County Emergency Services District No. 24** last year to the taxes proposed to be imposed on the average residence homestead by **Harris County Emergency Services District No. 24** this year.
