Harris County Emergency Services District No. 46 (HCESD No. 46) is currently seeking qualified candidates for the position of Firefighter. This is a fulltime, FLSA- 207k, hourly position.

#### **The Community**

HCESD No. 46 (Atascocita) is located 25 miles northeast of Downtown Houston and is bordered by the San Jacinto River, to the North; Lake Houston, to the East; The City of Humble, to the West and unincorporated Harris County, to the South. The district is a typical bedroom community of 74,000 residents. Close to shopping and entertainment, it is far enough from Houston to feel like a small town, but close enough to provide easy access to all the city has to offer.
