Sealed bids will be received by the Director of Public Service, 230 Clinton Street, Wauseon, Ohio, in the Council Chambers until 2:00 p.m. E.D.S.T. on Friday, August 2, 2019.

Bulk safety salt treated and suitable for ice control, road stabilization or dust control.

Bulk safety salt to be delivered via truck and dumped at the Public Works Storage Shed, Cole Street, Wauseon, Ohio.

Estimated usage – 800 tons.

Delivery to be for the period between November 1, 2019, and February 28, 2020, to be ordered in truck load lots not less than 21 tons. Delivery hours are from 8:00 a.m. to 4:00 p.m., Monday through Friday.

Pick up by City trucks to be for the same period in 10 ton truck load lots.

Each bid must contain the full name of every person or company interested in the same, and be accompanied by a bid bond or a certified check on some solvent bank, in the amount of ten percent (10%) of the bid as a guarantee.
