Signage- A sign stating the name of your business/organization may be included in the design of your entry.

Sound System- If you will be using a sound system, please fill out the appropriate spot on the registration form. **MUSIC MUST BE CONSISTENT WITH THE HOLIDAY THEME.**

NO "Santa Claus," Entries **DO NOT** use either a live Santa or Mrs. Claus or a representation of either character. The use of elves or other holiday characters is acceptable. This is because the final float in the parade is designated for Santa Claus. This will avoid duplication of characters and confusion for young spectators.

Goodies / Giveaway's / Handouts- Participants may do handouts, but with doing so safely.

No Hot Rodding, hole shots or wheelies will be allowed during the parade. This rule is in place to protect the spectators. If you are caught violating this rule, you will be disqualified from judging and will be removed from the parade.

Any participants that fail to comply with the request of local Law Enforcement or parade committee will be asked to leave lineup, parade, and/or lighting of the city.

Judging- At the judges stand, there will be a quick stop for the announcer. Judges will be at the center of town just before or after the Red light. Trophy winners will be posted on Greensboro Parks Board Facebook page on Sunday. Winners can pick up trophies at Town Hall starting on Monday.

Parking - Parking on parade route is prohibited. Please try and carpool to line up if possible to limit traffic. Parade route will end at the Greensboro River Park (old carnival grounds) if you would like to leave your vehicle there.

Rules- All children under the age of 18 whether walking or riding must have adult supervision. Drivers must have a valid driver's license and proof of insurance. All animals must have a designated clean up area personnel with proper clean up equipment

Parade Route- Parade will continue from Greensboro Supply down Sunset Avenue to Greensboro River Park (old carnival grounds). At that time you may pull into grounds or proceed up the bridge.

Lighting of the City- Following the parade, the town of Greensboro will be lighting the city. Santa Claus will have pictures with kids and family. Free refreshments and cookies are available. Feel free to stay after for our lighting event.

Lineup/Staging Area- Lineup will be at Greensboro Supply(far end of Sunset Ave.) If possible use Holly Road and enter Sunset Ave. Parade chairman will have final line up and you will be asked to fill out a intro card. You may just show up for the parade with out filling out the entry application, but you may be at end of lineup. ***All Participants Must Arrive At Lineup Staging Area (Greensboro Supply) No Later Then 5:45pm.***

The Town of Greensboro reserves the right to reject or alter any entry if it is deemed inappropriate or not fitting the holiday theme of the parade.
