SMOKE DETECTOR PROGRAM WAIVER AND RELEASE OF LIABILITY

NOTICE: BY SIGNING THIS FORM, YOU ARE ACKNOWLEDGING PRESCRIBED RISKS ASSOCIATED WITH THIS PROGRAM AND UNDERSTAND THAT YOU WILL BE ABDICATING CERTAIN LEGAL RIGHTS AS DESCRIBED BELOW. PLEASE READ THIS WAIVER CAREFULLY AND DO NOT SIGN UNLESS YOU UNDERSTAND ITS MEANINGS AND INTENTIONS

1. PROGRAM ACKNOWLEDGEMENT

I understand that, as a public service to promote fire safety and to help prevent loss of life, the Little York Volunteer Fire Department will provide free of charge, smoke detectors and batteries to one household as needed.

2. PERMISSION TO INSTALL

I understand that, as a condition to receive the necessary equipment free of charge, I will allow fire department personnel to enter my home to install, replace or service any equipment affiliated with the program, at a day and reasonable time of my choosing.

3. CLAIM OF ENDORSEMENT OR GUARANTEE

I understand that Little York Volunteer Fire Department does not now or ever endorse the brand of equipment being installed or the battery brand to operate them. I also understand that Little York Volunteer Fire Department neither offers, promotes nor extends any guarantee or warranty of any kind for said equipment or battery.

4. ACKNOWLEDGMENT OF RISK

I understand that smoke detectors do not prevent or extinguish fires that may occur. I understand that a smoke detector is used as an early warning device for the purposes of escaping from possible danger. I also understand that each smoke detector is free-standing and will not interact with any smoke or fire detection or suppression systems already installed and does not notify emergency services when activated. Hardwired or systems that provide notifications of alarms are beyond the scope of this Department and its' employees and must be serviced by qualified technicians through the alarm company of record.

5. USE OF EQUIPMENT

Printed instructions for the equipment being installed will be left with me for purpose, use and maintenance of equipment installed. I understand that I must use this equipment as stated and that the equipment may malfunction or not work at all if I deface, misuse, intentionally deactivate or otherwise circumvent any of the features of the equipment.

6. WAIVER AND RELEASE FROM LIABILITY

By signing below, I understand and agree to release, now and forever, members, officers, elected officials, directors, vendors, servants, agents, employees and all other associated parties from: Little York Volunteer Fire Department; Little York Volunteer Fire Association; Harris County Emergency Services District 17 from any claim or lawsuit made or attempted to be made on mine or any other occupants behalf for any injury, death or property damage which may or may not occur with the malfunction or failure of any and all equipment due to damage, defects, error in design, manufacture or installation. I have read and understand this form and place my signature freely.
