



Congratulations! By obtaining this application packet, you have taken your first step toward a rewarding and gratifying position as a member of the Ocean City Volunteer Fire Company. The purpose of the following information is to aid you in making one of the most important decisions you will ever face: whether or not to become a volunteer firefighter. The organization asks a lot **from** its members, but the organization gives a lot **to** its members in return. Below is a brief history of the Ocean City Volunteer Fire Company, membership requirements, and some general information.

## HISTORY

The Ocean City Volunteer Fire Company was founded in 1905. Efforts to organize a fire company prior to that date failed because of squabbles among the organizers. But in 1905, after a fire broke out completely destroying the Oriental Hotel, locals found the need for a contingent of firefighters and put their differences aside. The Ocean City Volunteer Fire Company as we know it today was borne out of that need.

The company was first housed in the old Methodist Tabernacle; ironically, that building caught fire and was irreparable damaged. The company was then moved to the corner of Dorchester Street and South Baltimore Avenue until money could be raised for a permanent structure. Once built, that structure was used until 1928 (it now houses the Ocean City Beach Patrol Headquarters) when it was exchanged for the current location of Station #2, 102 Dorchester Street.

Just as the mighty oak grows from the lowly acorn, so too have we grown. From a few members and a hand-drawn hose cart, the Ocean City Volunteer Fire Company has developed into a fleet of apparatus housed in five stations, operated by more than 200 professional men and women. The 75 members of the Ocean City Volunteer Fire Company Ladies Auxiliary support the Cadet corps as well as all aspects of the company's operations.

## MEMBERSHIP REQUIREMENTS

Applications will be accepted from any person 18 years of age or older. Those individuals between the ages of 14 and 18 are invited to join our cadet corps, of which a separate application is necessary.

You must reside within the old Tenth Election District/First Due Fire District boundaries to apply for active membership.

Those living outside of the aforementioned boundaries with previous fire training may apply for associate membership.

City employees with previous fire training may apply for contributing membership.

## THE APPLICATION PROCESS

Once one of the avenues for application has been fulfilled, simply complete the application, criminal background check authorization, and return to the administrative coordinator at the headquarters building, located at 1409 Coastal Highway.

After contacting your references, conducting your criminal background check, and a physical examination, an attempt to contact you, at the telephone number you provided on your application, will be made by the corporate secretary. You will be invited to attend the next regularly scheduled meeting of the Board of Directors (monthly on the first Wednesday, commencing at 7:00 PM) for a personal interview.

After a satisfactory personal interview, and a majority vote in the affirmative by the Board of Directors, you will be given a conditional offer of membership. The next individual you will be contacted by will be a mentor, assigned to you by the Ocean City Volunteer Fire Company. This individual will set up a time and place to meet with you and explain the remaining steps in the application process, including:

- Medical Evaluation (at no cost to you)
- Rookie School
- MFRI Firefighter I (a 108-hour course in basic firefighting)
- Probationary Member Requirements Sheet
- Probationary Period and Points System

## THE DEMANDS

Firefighting is an ultra-hazardous, unavoidably dangerous undertaking. However, today's firefighter is no longer simply called to extinguish fires. Today's firefighter is charged with mitigating a multitude of emergencies. Examples of these types of emergencies include, but are not limited to:

- Hazardous Materials Incidents
- Confined Space Rescue
- High Angle Rescue
- Water Related Incidents
- Motor Vehicle Entrapment Rescue
- Assisting Emergency Medical Crews
- Machinery Rescue

These calls are in addition to the numerous hours spent in regular business meetings, committee meetings, company drills, in station stand-bys, advanced training, and performing collateral duties. The position of a volunteer firefighter in today's world of ever-increasing societal demands requires discipline and sacrifice. While your family is fast asleep at three o'clock on a cold February morning, you may be walking the floors of a north-end high-rise searching for the cause of a fire alarm activation. While your friends are out celebrating the world championship of your favorite sports team, you may be helping a person who is trapped in their vehicle because of a crash. While your Thanksgiving dinner is getting cold, you may be assisting a medic crew on a full cardiac arrest. Emergencies know no holiday. Nor do they show preference to time of day, weather, or personal plans. In short, you may be called to action at any time, and being a member of a volunteer fire company, who is going to answer the call if you do not?
