Description: Full-Time Emergency Medical Technician / Firefighter

Nature of Position:

- Employee will be responsible for staffing our basic life support ambulances, providing emergency medical care and transportation
- Employee will be responsible for staffing fire apparatus on an as-needed basis
- Employee must be able to perform the related duties associated with these functions

Responsibilities:

- Provide basic life support care and transport of the sick and injured
- Complete related EMS, fire and rescue documents associated with these tasks
- Routine checks of EMS/fire/rescue equipment and vehicles
- Light preventive maintenance (fuel fills, oil check and fill, etc.)
- Perform housekeeping duties
- Assist with fire prevention, administrative functions and logistical support as needed
- Other responsibilities may be added if the need arises
- Employee must show initiative at promoting the team concept

Hours of Work: Full time (24/72)
